Policy Name: Sun Protection Policy

Purpose

The purpose of this operational policy is to keep children and adults safe by meeting Licensing Criteria **HS27** – Child Health and Wellbeing, and 46 Health and safety practices standard of the Education (Early Childhood Education) Regulations 2008.

Position Statement

As part of the centre's commitment to protect children from harm we minimise the risk of exposing children to excessive ultraviolet radiation (UVR) that causes sunburn, skin damage and increases the risk of skin cancer.

We recognise the importance of having a balance between increasing the risk of skin cancer and getting enough sun exposure for children to maintain adequate levels of vitamin D. Between April and August (approximately) children will be encouraged to actively enjoy the sun and not wear sunhats, sunscreen or play in the shade.

Issue Outline

Enjoying the outdoors is a key part of the early childhood education experience, as is the safety and wellbeing of the children enrolled in our service. The risks associated with exposure to the sun can be significant and can also be managed so that play and learning outdoors can occur safely.

Detail

Whilst there is no statutory obligation to have a policy and procedure to protect children from the sun, there is the regulatory requirement to promote good health and safety and to keep children from harm. This policy is in place to ensure children are safe and comfortable when they are outside and parents are informed of how the centre keeps them safe from excessive sun exposure.

Parent and family awareness is promoted by our centre in many ways, including:

- At enrolment
- · General conversations

- Providing a copy of our centre's sun protection policy
- Other seasonal promotional activities.

We will apply sunscreen to exposed skin for any child playing outdoors in sunny conditions, unless parents specifically refuse this and this is noted in the enrolment form.

Our centre provides sunscreen cancer society SPF50+. We will apply when the UV Index is 3 and above and reapply 3 hourly during the day.

As sunscreen is not a medicine, it does not need to be authorised or acknowledged in the same way that medicines do.

Parents are not required to sign for sunscreen on a daily basis.

We keep a sunscreen chart to keep track of how often children have had sunscreen applied and all staff have the correct information when sunscreen was applied last. This chart is located on the deck outside

All sunscreen supplied by parents is individually named and all staff are informed.

Older children are encouraged to apply their own sunscreen under adult supervision to develop a routine of being sunsmart.

Adults will take precautions to avoid spread of infection whilst applying sunscreen, particularly to children's faces. A high degree of hygiene is expected.

We will require all children playing outside in sunny conditions to wear a sunhat. This will be monitored.

We ensure all children playing outside during sunny days maintain good hydration practices.

We ensure all children playing outside during sunny days wear appropriate clothing so their skin is protected.

The centre provides shaded areas through use of shade sails, well established trees and the use of umbrellas if required.

Impacts of Policy on Staff, Parents, Children

- Eye damage
- Sunburn and skin damage (immediate) and risk of skin cancer
- Unhappy children and parents

Implications and/or Risks

• Children playing outside in direct sunlight during the times when the UV Index is 3 or above are at risk of sunburn, overheating, sunstroke, or dehydration.

Clear procedures have been developed and staff trained to follow them.
